2. **Payment.** You understand that any and all sessions must be booked through LFG's online portal. You understand that payment is due in full at the time the RTT session is booked as evidenced by LFG confirming the appointment by either email or text message.
3. **Cancellations.** You understand that LFG requires a 24-hour cancellation notice prior to my appointment time. You understand that any and all session(s) must be cancelled through LFG's online portal or by email notification at [hello@lawsonfinancialgroup.com](mailto:hello@lawsonfinancialgroup.com). No voicemail messages will be accepted.

You understand that we will refund the full amount paid for the RTT appointment, PROVIDED YOU GIVE US 24-HOURS' NOTICE.

You understand that if you cancel an appointment with less than 24 hours' notice, that LFG reserves the right to withhold a cancellation fee, the amount of which is outlined in the cancellation fee schedule below. You understand that LFG will refund the fee paid for the RTT session LESS ANY CANCELLATION FEE that applies. Refunds for cancellations will be made to the same payment method used to book the RTT session.

#### CANCELLATION FEE SCHEDULE:
